#### MINIMUM ELIGIBILITY CRITERIA FOR PARTICIPATION

1. The Bidder (individual/ Firm/ Company), should have registered offices in India and should be in existence for at least the last 5 years.

Documentary evidence in form of Certificate of Incorporation (Copy) issued by Registrar of Companies/Firms/ MUST be produced.

2. The Bidder or the OEM of the offered product must have ISO 9001:2015 certification

Documentary evidence in form of Copy of ISO certificate MUST be produced.

3. The Bidder MUST have experience for the supply of External Connectors for Window server and Clustering Software for application and Data Base Server.

Copies of work order issued by the various Govt. Departments/Autonomous body/ corporation/boards for the supply of External Connectors for Window server and Clustering Software for application and Data Base Server must be supplied. Order value must not be less than 20.00 lacs in each year during the last three financial years meaning thereby total value of work orders supplied should be 60.00 lacs during the last three financial years.

#### PROJECT BACKGROUND AND SPECIFICATION & QUANTITY OF DESIRED SOFTWARES

Project "Phoenix" has been implemented by Samagra Shiksha, UT Chandigarh to assess students' progress at elementary level for all subjects and to ensure that all students acquire at least minimum levels of learning. Mobile app based on Phoenix Project has been developed and is implemented in all Govt. Schools to track the progress of Students and Teachers on monthly basis.

The scope of work of this Tender is to Supply and Installation of External Connectors for Window Server 2019 and Clustering Software for Application and Data Base Server. ### 3. The Bidders MUST QUOTE for all the ITEMS. Bids submitting partial quote of items shall be summarily rejected.

- 4. The Bidder shall bear all the costs associated with the preparation and submission of its bid, and department will in no case, will be responsible or liable for these costs, regardless of conduct or outcome of bidding process.
- 5. The bidder has to upload the checklist duly index/page numbered on its letter head duly signed by the authorized signatory and other supporting documents as asked for in the bid in scanned format. Failing to submit the same or non-compliance/deviation/legible or blurred copy from any bid terms and conditions, eligibility criteria or technical specifications shall result in rejection of the bid.
- 6. The Bidder has to examine all instructions, forms, terms, conditions and specifications in the bidding documents. Failure to furnish all information required by the bidding documents or submission of a bid not substantially responsive to the biding documents in every respect will be at the Bidder's risk and will result in rejection of its bid.
- 7. Amendment of Bidding Documents (Corrigendum):
  - *i.* At any time prior to the deadline for submission of bids, Purchase cum Technical Committee may, for any reason, whether on its own initiative or in response to the clarification requests by a prospective bidder, modify the bidding documents.
  - ii. The corrigendum will be published on website www.ssachd.nic.in and http://tenders.chd.nic.in/nicgep, if any.
  - *iii.* In order to allow prospective bidders reasonable time to take into consideration the amendments while preparing their bids Purchase cum Technical Committee, at its discretion, may extend the deadline for the submission of bids, if so required.
- 8. Bid Currency Prices shall be quoted in Indian Rupees only.
- 9. Price shall be inclusive of out-of pocket expenses and all taxes, duties, freight, forwarding, transit insurance and installation charges etc. as per PRICE Bid proforma.
- 10. Late Bids shall be rejected.
- 11. Modification and Withdrawal of Bids:
  - i. No bids will be allowed to be modified subsequent to the final submission of bids.
  - *ii.* No bid will allowed to be withdrawn in the interval between the deadline for submission of bids and the expiry of the bid validity.
- 12. Financial Bids shall be opened in the presence of technically qualified bidders. Pre-intimation will be given via e-mail/whatsapp/telephonically.
- 13. Evaluation of the bids: After the closing time of submission, Purchase cum Technical Committee will evaluate the downloaded documents with reference to DNIT as per bid terms and conditions. The recommendations of the Purchase cum Technical Committee will be uploaded on the website.
- 14. Delivery and installation: The bidder should deliver and install the requisite software within a period of 2-4 weeks from the date of issue of work order, The paper license for the software must be delivered in the name of "State Project Director, Samagra Shiksha, UT Chandigarh".
- 15. Bids Cycle shall be valid for 90 days. Finance Bid so uploaded shall be valid till 31<sup>st</sup> March, 2022. A bid valid for a shorter period shall be rejected as non-responsive.
- 16. The bid will not be accepted if the copy of EMD demand draft amounting to Rs.60,000/- is not uploaded on the website. EMD amount less than Rs.60,000/- is also not accepted. EMD to unsuccessful bidders would be returned after the finalization of financial bid and no interest shall be paid.
- 17. Penalty Clause:

If the bidder fails to deliver and install the requisite software within 2-4 weeks from the date of issue of work order, then a sum equivalent to one percent (@1%) of the total contract value shall be deducted from the payment for each calendar week of delay or part thereof subject to a maximum of @10% of contract value. The paper license for the software must be delivered in the name of "State Project Director, Samagra Shiksha, UT Chandigarh"

within 6 weeks from the date of issue of work order.

- *i.* Delay in excess of 10 weeks will be sufficient to cause for cancellation of work order. In that case the EMD of the bidder will be forfeited.
- 18. Warranty Support: One year onsite free re-installation warranty support.

#### 19. Payment:

- ii. @100% payment will be made on successful report furnished by the SPIC, Chandigarh Administration regarding supply and installation of the ordered products.
- iii. No advance payment shall be made.
